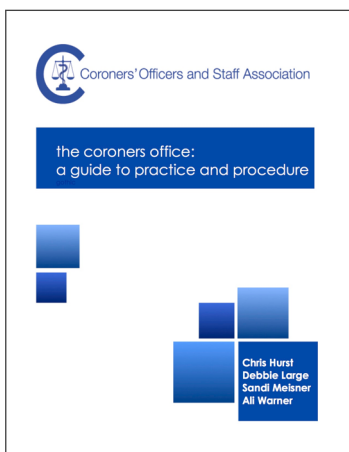

COASA is working to promote and advance the professional standing and excellence in working practices of coroners officers and coroners staff in order to enhance the service provided to bereaved people, coroners and associated professionals

FULL a person directly responsible to the coroner with a role in the procedures for dealing with unexpected or unnatural deaths

ASSOCIATE a person who was previously a full member and has moved to other employment but still has responsibility to the Association to further its aims*

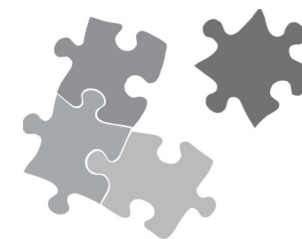
AFFILIATE a person who does not qualify under other categories but shows a proper interest in the Association*

STUDENT a person enrolled on a relevant course and is not eligible for full membership*

OVERSEAS a person working overseas with a similar role to that of a full member

RETIRED a person who was a full member prior to retirement from employment
